

**CENTURYLINK / DENVER BRONCOS BOOSTBOX SWEEPSTAKES
OFFICIAL SWEEPSTAKES RULES**

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF BEING SELECTED TO PARTICIPATE OR WINNING A PRIZE.

Sponsor. CenturyTel Service Group, LLC and the Denver Broncos (“Sponsor” or “Sponsors”)

Eligibility. Entrants must be at least 18 years of age and legal U.S. residents. The CenturyLink / Denver Broncos Boost Box Sweepstakes (“Sweepstakes”) is only available to those persons who are legal residents of Colorado residing within 75 miles of downtown Denver, Colorado with zip codes: 80204. Employees of Sponsors, any affiliate of Sponsors, any of their advertising or promotional agencies, any sponsor of any prize offered in this Sweepstakes or any business or entity involved in the development, production, implementation, administration or fulfillment of this Sweepstakes, the National Football League (“NFL”) or its member clubs, including, without limitation, the Denver Broncos, and their immediate family members (defined as biological, foster or adoptive parent, stepparent, a biological, foster or adoptive child, step child or legal ward or a person whom the employee has (or had during the person's youth) daily responsibility and financial support, current or former spouse, father, mother, brother, sister, son, or daughter) are not eligible to participate.

Entry Period: There will be eight separate Entry Periods over a seventeen week period (bi-weekly) as outlined below. **On-line entries begin at 10:00 a.m. Mountain Time ("MT") on the first day of each Entry Period and end at 11:59 p.m. MT on the last day of each entry period.**

Entry. There are two ways to enter the Sweepstakes. Limit one entry per person per Entry Period; this includes both online and mail-in entries. If multiple entries are made during an Entry Period with the same Entrant name, date of birth and address/account, only the first entry received will qualify as the entry and the rest will be disqualified. Once an Entry Period winner is determined, all remaining entries from that Entry Period will be discarded.

On-line entries will be declared made by the authorized account holder of the e-mail address/social media account ("account") submitted at time of entry. "Authorized account holder" is defined as the natural person who is assigned to the account by an Internet access provider, online service provider or other organization (e.g., business, educational, institution, etc.) responsible for assigning accounts for the domain associated with the submitted account. Winner will not have the right to substitute another prize package. Any difference between the stated approximate retail value of any prize and the actual value of such prize will not be awarded. Prize Winner Selection and Notification. A random drawing for each Entry Period (as outlined above) will be conducted by an authorized CenturyLink representative whose decision will be final. In the event the person originally selected as the winner is disqualified or does not respond within 1 days, the prize will be given to a second winner chosen via a random drawing of the remaining entries, conducted within five days of such disqualification.

Prize Acceptance. All Winners must complete, execute and return an affidavit confirming the winner's identification and eligibility including a Liability and Publicity Release.
